RESOLUTION NO. 2020-41

A RESOLUTION OF THE BOROUGH OF BRENTWOOD, COUNTY OF ALLEGHENY AND COMMONWEALTH OF PENNSYLVANIA, AUTHORIZING AN AMENDMENT TO THE AGREEMENT BETWEEN THE BOROUGH OF BRENTWOOD AND WASTE MANAGEMENT, WHICH IS ASSOCIATED WITH REFUSE COLLECTION, TO ESTABLISH A HOUSEHOLD HAZARDOUS WASTE COLLECTION PROGRAM.

WHEREAS, the Borough of Brentwood participates in the South Hills Area Council of Governments (SHACOG) Solid Waste Collection, Removal, and Disposal Joint Bid; and

WHEREAS, through said partnership, the Borough entered into an Agreement with Waste Management for the removal of refuse and recycling for the period of January 1, 2019 through December 31, 2023; and

WHEREAS, following the adoption of the Covered Device Recycling Act of 2010, it has been unlawful to dispose of televisions, computers, and other electronics in landfills; and

WHEREAS, as retailers have retreated from the provision of free electronic recycling services, it is now exceptionally difficult for Borough residents to discard unwanted electronics without paying significant processing fees; and

WHEREAS, Waste Management will remove electronics, as well those household chemicals that have long been banned from landfill disposal, via its Household Hazardous Waste Collection Program; and

WHEREAS, Waste Management submitted a proposal for this service as part of the Joint Bid, and the Borough is able take advantage of this pricing structure; and

WHEREAS, Brentwood Borough Council asserts that, at less than one dollar per household per month, this service provides an economical mechanism by which to remove from our community those unwanted materials that are potentially harmful to our natural environment; and

NOW, THEREFORE, BE IT RESOLVED AND ADOPTED by the Council of the Borough of Brentwood, County of Allegheny and Commonwealth of Pennsylvania, and it is hereby **RESOLVED AND ADOPTED** by the authority of the same that:

1. The Borough of Brentwood hereby accepts and approves Amendment No. 1 to the Articles of Agreement negotiated with Waste Management for refuse disposal to



- establish a Household Hazardous Waste Collection Program, and said Amendment shall be substantially similar to that attached hereto as **Exhibit 1**
- 2. The Borough Manager is authorized and directed to execute Amendment No. 1 on behalf of the Borough, and which Amendment shall be substantially similar to **Exhibit 1** attached hereto, subject to the review of the Borough Solicitor.
